SECTION 1: INVITATION FOR BIDS

(A) INTRODUCTION and OBJECTIVE:

(i) Introduction:

Assam Power Generation Corporation Ltd. (APGCL) is a state GENCO operating in the state of Assam and with the vision of availability of reliable and quality power at competitive rates and on a sustainable basis.

APGCL has various gas based thermal power plants as well as hydro power plants. The gas based thermal power plants Namrup Thermal Power Station/Namrup Replacement Power Project located in the District of Dibrugarh, Assam has combined installation capacity of 139.4 MW.

(ii)Objective of the Tender:

Namrup Replacement Power Plant (NRPP) is a gas-based power plant consisting of one Gas Turbine (GTG) and one Steam Turbine (STG) units with total installed capacity of 98.4MW. The STG unit with installed capacity of 36.15 MW is connected with the GTG unit. The NRPP was commissioned on 16.07.2021. The performance of the Steam turbine is directly proportional to the performance of the condenser. Now the performance of the condenser is gradually decreasing. So, NRPP, APGCL intends to carry out the cleaning of condenser of the STG as no cleaning of surface of the condenser tubes was done since its installation.

The objective of this tender is to finalized a bidder through tender for inspection, testing, cleaning and recommissioning of the said condenser.

(B) Intent of Tender:

The intent of this tender document is to furnish the work scope for execution of inspection, testing, cleaning and recommissioning of the condenser of the STG unit of Namrup Replacement Power Plant as well as provide techno-commercial specification of requirements to be furnished and fulfilled by the bidders participating in the tender.

(C) Eligibility of Bidder:

The bidder must fulfill the following criteria to participate in the Tender.

- The bidder must have past experience of successfully executing of condenser cleaning in any reputed thermal power plant having unit size not less than 30MW by high pressure hydro jetting during past 5 years counted from the date of floating this E-Tender either having the following work order value.
 - i. The contractor executed one similar work not less than 5.0 lakhs,
 - ii. The contractor executed two similar works each execution value not less than 3.0 lakhs, or
 - iii. The contractor executed three similar works each execution value not less than 2.5 lakhs

- 2. The bidder must have an average annual turnover of at least Rs.3,00,000/- (Rupees three lakh) only during the last 03(three) financial year, FY 2021-22, 2022-23 and 2023-24
 - In this regard, a certified copy from the Chartered accountant should be submitted by the bidder along with their technical bid.
- 3. The bidder should not have been black listed by any State Government, Central Government, PSU of state/central, private company etc. Notarized documents in this regard are to be submitted in technical bid.
- 4. The bidder should have valid GST registration certificate & Pan Card.
- 5. Copy of income tax return (ITR) of the last 03 (three) Financial Year (i.e., FY 2021-22, 2022-23 and 2023-24 of the bidders.
- 6. The bidder should have valid labour license.

(D) SCOPE OF WORK:

The scope of work of the successful bidder shall be as follows -

1. Pre shut down activity:

The successful bidder shall have to complete all official formalities as per bid document before taking machine shut down.

- a. Mobilization of man, equipment and arrangement of adequate branded proven chemicals such as acid, corrosion inhibitor, silica remover, neutralizer, passivation as required for successful completion of chemical soaking and chemical circulation.
- **b.** The contractor shall arrange high pressure (as mentioned below) hydro jetting equipment of either electrical or engine driven whose discharge pressure adequate for the cleaning work.
- c. Recording of running parameters of surface condenser.
- d. The contractor shall have to engaged minimum two numbers of hydro jetting machine each should be equipped with minimum two numbers of launches so that hydro jetting could be carried out in all four (4) isolated chambers of the condenser at the same time round the clock as per predefine pressure and discharge flow.

2. Shut down activity

- a. Opening of condenser manhole cover.
- **b.** Physical inspection of water tubes & shell side for any leakage etc.
- c. Carry out condenser cleaning in the following sequence:
 - i. Pre-hydro jetting to remove all loose debris/scales and make through all condenser tubes have passes for chemical circulation.
 - ii. Chemical socking.
- iii. Chemical circulation.
- iv. Final hydro-jetting to remove all loose scale.
- v. Neutralization.
- vi. Cleaning of water boxes.
- vii. Closing of condenser manhole cover.

- **viii.** Leak test of condenser: In case of detection of tube(s) leakage after completion of condenser cleaning, plugging of the said tube(s) shall be under the scope of this contract.
 - ix. Hydro jetting of condenser tubes shall be carried out through manhole only.
 - **x.** Arrangement of chemical tank, isolation valve, chemical circulation pump and associated piping including installation for chemical circulation shall be under the scope of contractor.
- **xi.** Contractor shall ensure adequate flow of chemical circulation with selection of suitable chemical circulation pump.
- xii. Job is to be carried out by experienced and certified technicians (Necessary and relevant certificate to be produced during execution of the work).

3. Post Shutdown Activity:

- a. Recording/joint monitoring of operating parameters such as inlet & outlet water pressure of surface condenser and water differential temperature at optimum operating condition, differential pressure and hot well temperature etc.
- **b.** Preparation of a joint report of "Work completion and operating parameters with APGCL".

4. The scope of the owner:

- a. Supply of clean water at normal pressure. Bidder to furnish water requirement prior to manpower mobilization.
- b. 415 V AC, 3 phase electrical power supply to work place.
- Service air at 100 psi if necessary.
- d. Illumination during the work if necessary.
- e. Accommodation may be provided on fully chargeable basis.

2. Firm Price: The basic price(s) quoted by the bidder shall be firm without any variation in any way till completion of the work in full. The basic price and all other applicable taxes & duties shall be also quoted in the price bid of the submitted tender.

3. Terms of Payment:

The condenser tube cleaning shall have to be completed preferably within 10(ten) days from the date of site handover. The cool down period, opening and closing of manhole covers, water draining and refilling etc. are included in the above completion period.

- 6. Performance security deposit: The successful bidder shall furnish a Performance Security deposit equivalent to 10(ten)% of the total contract value in the form of a Bank Guarantee from a nationalized/scheduled bank of RBI, immediately within 10 (ten) days from the date of receipt of the LOI/Work Order dully pledged in favour of the Asstt. The PBG/Security deposit shall be valid till entire guarantee period with additional 45 (forty five) days for covering required claim period and must be in prescribed format as attached with the bid document (Annex-II).
- 7. Liquidated damage: In case of delay in work completion beyond the work completion period as mentioned in clause in "G 5", APGCL shall be entitled to: -
