<b>Name of the work</b>	<b>Supply, fabrication, erection, testing and commissioning of 12" gas pipe line along with valves, flanges and all accessories including laying of the pipeline as per modification required for installation and commissioning of gas flow meter, gas chromatograph and pressure control valve in the existing gas station of LTPS.</b>
<b>Bidder</b>	The bidder must be a reputed fabrication and erection firm fulfilling all the requisite criteria of the bid document. The bidder must be a Manufacturer or Manufacturer's Authorized Firm for pipes, valves, flanges, etc. used under the norms of Petroleum & Natural Gas Regulatory Board (PNGRB). The products offered by the bidder must conform to the standards specified by API, ASME, ASTM and so forth. Necessary documents in this regard must be furnished along with the technical part of the bid, failing which the bidder's submitted tender may not be considered for evaluation. Also, in case of Authorized Firm, necessary documents of authorization from the Principal/Manufacturer to be furnished along with the technical bid, failing which the submitted bid will be rejected. In case Work Order is placed to the bidder, the bidder must procure and supply the ordered materials from the manufacturer/principal whose authorization was furnished along with tender. Necessary Challan copies of manufacturer/principal in this regard must be produced at the time of supply.
