Or Three similar completed works each costing not less than amount equal to 40% of the estimated project cost for consultancy work. b) Similar completed works means geotechnical investigation through exploratory drilling and geophysical survey (ERT/SRT) works of any hydro project. ii) Minimum Average Annual Turnover shall be Rs. 30 Lakhs (Rupees Thirty Lakhs only) during the last 3(Three) preceding financial years. iii) Net Worth of the bidder should be positive for the last 3 (Three) preceding financial/ accounting year.
